# What's Happening?

### **Council Meetings**

Council Agendas with reports and Minutes are listed on the Noosa Council website. 'noosa.qld.gov.au' These are a valuable source of information as to how the Noosa Shire and Council are performing and being managed on our behalf. You can also watch Noosa Council meetings on the internet live streaming on 'Youtube'.

Go to www.noosa.qld.gov.au then follow the menus to 'council' and 'meetings'. Council has an online consultation system that is a great source of information with a great facility for feedback. Go to noosa.qld.gov.au Website, and under 'quicklinks' and 'your say noosa', find the current consultative projects and a wealth of reports. A real opportunity exists to contribute and get involved.

# SEQ Regional Plan.

Of great concern is the push by the State government to substantially increase population of our Shire with resulting increases in congestion, traffic, etc. "Gentle Densification" of SE Qld means more people in a smaller space.

#### The Noosa Plan

A strong Planning Scheme remains our best protection from changes to policy resulting in weakened regulation which would adversely affect residents' amenity. Strong enforcement is required The push for Noosa to take significant increases in population as SEQ grows and is also a source of pressure on our lifestyle, already under threat from vested interests.

## **Current Issues:**

**The Noosa River Catchment Plan** implementation has been pushed away until July 24 and is currently under attack from some Councillors – interesting meeting - and business groups. See explanation in 'Noosa Matters' State government plans for marine safety improvements are slowly being implemented.

**Noosa Shire Housing Strategy.** Some of these problems are years in the making. Council, State and Federal governments are trying to find solutions but have serious concerns about the potential impacts on our small Shire.

# **Local Law - short** stay letting and home hosted accommodation.

Noosa Council adopted a new local law for short stay rental accommodation regulating the ongoing operation of short stay letting. It is somewhat managing the impacts on neighbours. Remember, Noosa Council **24hr Complaints Hotline** is **53296466** to report issues. These businesses are required to display their registration number.

**Kin Kin Quarry Issue** – Ongoing issues continue with dangerous quarry trucks. The people of the hinterland are currently awaiting a Court decision.
